- c. Discussion and possible action on addressing antisemitism in Pico Robertson especially as it relates to Sabbath Observant Jews being targeted on the Sabbath when they do not carry phones. Update: Increase Shmira Public Safety Patrols: Robbery at gunpoint for a watch value \$50K – Victim did not report to police because it was the Sabbath, Oct. 5. Victim did not report to anyone until October 8 to the Shmira Public Safety. No police report has been filed yet.
