  Dear Los Angeles Department of Transportation,
  We, the South Robertson Neighborhoods Council, would like to request that this Agency address unsafe parking practices on the south side of 18th street, between Holt and La Cienega. This portion of the street consistently has oversized vehicles, such as pickup trucks and RVs, parked on it. This makes it difficult and unsafe for cars to pull into and out of the parking area of the adjacent shopping center. These vehicles also make it extremely hard to see pedestrians, decreasing their safety as well. The SORO NC requests the City paint red curbs 15 ft before all entrances and exits from the shopping center, as well as all street corners. Additionally, this portion of 18th St already has a 6000 lbs restriction. We kindly

Please note that under the Brown Act, the Board is prevented from acting on matters brought to its attention during the General Public Comment period; however, the issue may become the subject of a future meeting. In the interest of addressing all items on the agenda, time limits for individual comments and discussion may be set at the discretion of the Chair.

All items on the consent agenda will be determined by a single Board vote and without Board discussion. Board members may request that any item be removed from the consent agenda and considered individually at any time prior to that vote.
