Summary: The South Robertson Neighborhoods Council agrees with the motion in this Council File that identifies the problems with the current signal infrastructure for rapid transit in the City, including slowdowns to high-use transit and confusing traffic patterns leading to accidents.

We hope that LA DOT and Metro's plan on updating and improving transit signaling will result in faster, safer, and cleaner transportation for the City. We believe that signal prioritization has the potential to greatly improve several transit lines throughout the City, such as the light rail E Line that is heavily used by South Robertson stakeholders.
