Mitch Cohen updated Land Use mentioning a situation in which a multi-unit structure was being developed and the issue was around whether it would have parking or no parking; one projection under consideration was a 7 floor unit that would no offer parking.

Terence Gomes said it could become a criteria for affordable housing developments to not have to offer parking; and that they would get priority for water and power. Mitch Cohen said it would be automatically granted and that Land Use would be opposing it. Michael Lynn said Outreach would probably be needing more volunteers especially if any of their motions pass.

Multiple Public Comment (Item): No Public Comment.

a. Motion for the SORO NC to submit a Community Impact Statement (CIS) in support of the motion in Council File 21-1224 to add cameras to Metro buses to improve enforcement of ticketing for cars parked in bus-only lanes (GB101524-20)

Joel Weinberger proposed a substitute motion to replace this item with thank you letters to CD 5 and CD 10 using the same language.

Moved by Joel Weinberger; Seconded by Terrence Gomes.

Joseph Mollaie asked what the fiscal impact would be?

Joel Weinberger replied 5.2 million a year.

Terrence Gomes asked why the city was putting cameras on a bus?

Michael Lynn said a new state law allowed them to put cameras on a bus.

Terrence Gomes asked why would we be paying for this if it is part of Metro.

Joel Weinberger said because it would be enforcing city parking rules.

Joseph Mollaie said cars are constantly using bus lanes; bus lanes should not be there.

Eitan Gershov asked if the ticket was automatic or issues by the bus driver.

Michael Lynn responded it would be automatic; noted it was a slippery slope being against the CIS and for the thank you letter.

Baila Romm added that the board did a good job.

Joseph Mollaie had a question over the notion of election versus selection.

Terrence Gomes said internally we use selection but in general we would use the term election. Michael Lynn said they are recommending a \$6,500 budget; if approved the Budget Committee would have to adjust it.

Michael Lynn informed the board that this was based on other Neighborhood councils.

Michael Lynn added there would be 12 seats available.

Jason Plummer said he would prefer to spend \$1800 on bus benches rather than postcards.

Joel Weinberger said this was in response to a stakeholder requesting instructional markings on that street. They only want a left turn lane not a light.

Substitute motion to send letter to CD 10 and LA DOT. Moved by Terrence Gomes; Seconded by Baila Romm.

Joseph Mollaie commented saying he did not think there was enough room.

Terrence Gomes said that was up to D.O.T.

Holly Hubsher asked if a lane would be taken away.

Joel Weinberger said no.

Michael Lynn said the markings would form a full lane.

Terrence Gomes said originally there was a De facto lane.

Jason Plummer added that he would like to see a right turn lane on La Cienega.

Terrence Gomes said this motion should be requesting a traffic study.

Michael Lynn responded that it already was in the letter; he added they will do one amendment with all the language.

Mitch Cohen said getting a signal light through the D.O.T. is impossible but street lanes are easier.

Jason Plummer added he preferred signals.

Motion to amend language of letter to request a traffic study and do a feasibility study yanking the left turn signal out.
