She said many neighbors have come to her knowing she is an attorney and telling her about Police abuse/brutality; furthermore she stated her goal was to have healing on her side of the community and have them participate on their turf, Hamilton High; she concluded by saying most neighbors complain that things are not done on their side of town.**

**Jason Plummer said Hamilton High is a good location and the school could promote the event.**

**Joseph Mollaie mentioned that whenever we decide to have this event we should blanket the area with signs, advertisement.**

**Katelyn Best suggested presenting the language differently; more inviting.**

**Terrence Gomes said he knew all those neighbors and has not heard anything about police brutality or abuse.**

**Margarita Guzman said many neighbors have personally spoken to her about these issues; and that for many English is not their first language.**
