Michael Lynn also mentioned that the City Council took their advice opposing SB 79 and that the Mayor signed on to it as well yesterday, as official opposition.

Jason Plummer discussed the LA 100 Project from LADWP, a green energy project; he mentioned they would be doing an online presentation and discussing battery storage efforts, also adding that they have gone completely off coal and announcing they had implemented 45,000 electrical vehicle chargers.

Beth Klein asked where the batteries were being stored.

Jason Plummer said it was in Kern county and it is sent through the lines; he said it would provide an extra 150 mega watts.

Michael Lynn said the court order was from Judge Carter; he added that the Mejia audit would see specifically where the money goes at all levels, this audit would discover what went where.
