- b. Discussion and possible action regarding Beverly Bites - 8600 W. Pico Blvd. Unsafe conditions exist regarding delivery services parking illegally when picking up food for delivery. It's a public safety issue with double-parked cars, causing congested streets and a traffic hazard for both pedestrians and cars at Pico and Holt. **Ryan Spivey stated that Holt is the most congested. There is not sufficient parking for the delivery drivers. Possibly designated parking spots. The drivers park in red zones. Parking enforcement to patrol. Send a letter to CD 5 to contact Beverly Bites. Is it possible for the designated areas for parking for the delivery drivers to pick up on alley only. They need signage from Beverly Bites.**  
**Parking enforcement. The delivery drivers park in the red zone on the east and west side of Holt.**  
**Motion to for the SORO NC to send a letter to CD5 requesting that they send a letter to Beverly Bites requiring that they make adequate and safe arrangements their delivery drivers to parking.**
