SORONC - Bylaws Committee 2026 Bylaws Revision Recommendations

1 **Whereas**, Article XIII of the South Robertson Neighborhoods Council (SORONC)
2 Bylaws provides that amendments to the Bylaws may be proposed by Board Members or
3 Stakeholders and reviewed by the Bylaws Committee before consideration by the Board;

4 **Whereas**, the SORONC Bylaws Committee has reviewed the governing document and
5 identified formatting inconsistencies within Article II and Article V;

6 **Whereas**, the Bylaws Committee recommends standardizing the formatting in Article II
7 by replacing lowercase lettered sub-items with numbered sub-items and in Article V by
8 replacing numerals with capital letters;

9 **Whereas**, the Bylaws Committee recommends revising Article V: Governing Board,
10 Section 1: Composition on page 8 by striking the term “Stakeholders” so that the section reads:

11 “Section 1: Composition The Board shall consist of twenty-five (25) positions elected by
12 the NC Stakeholders, or selected or appointed by the NC Board Members.”;

13 **Whereas**, the Bylaws Committee further recommends revising Article V: Governing
14 Board, Section 1: Composition on page 9 by removing the phrase “at the request of the Board”
15 from the final clause following items 1–5 and replacing the clause with the following language:

16 “If the Stakeholder status of a Board Member is in question, then the Department will
17 verify status using the Department’s procedure.”;

18 **Whereas**, the Bylaws Committee has also identified an error in Article III: Boundaries,
19 Section 1: Boundary Description, Item 4 on page 6 and recommends correcting the clause by
20 striking the first instance of “Pico Blvd.”, inserting “from Pico Blvd. to” after the first instance
21 of “Motor Ave.”, and adding “from Club Dr. to the 10 Freeway” at the end of the clause;

22 **Whereas**, the corrected boundary clause shall read as follows:

23 “West (starting at the Beverly Hills border and heading south) Beverly Hills border near
24 Beverly Green Dr., Motor Ave. from Pico Blvd. to the southern border of Hillcrest
25 Country Club, Anchor Ave. connecting east of Girila Way to Club Dr., National Blvd.
26 from Club Dr. to the 10 Freeway.”;

27 **Whereas**, these amendments are being sponsored and recommended for adoption by the
28 SORONC Bylaws Committee.

30 The South Robertson Neighborhoods Council (SORONC), acting through its Board,
31 does enact as follows:

32 **Therefore, be it resolved**, that the Board of the South Robertson Neighborhoods
33 Council approves the above amendments to the SORONC Bylaws and directs that the approved
34 amendments be submitted to the Department of Neighborhood Empowerment for review and
35 final approval.
